Our objectives for our recreation programs are to offer a fun activity that is organized and led by a Senior Center member. Participants socialize, build friendships, have fun, and often learn something new. 11,263 duplicated participant units.

Health and Fitness - These programs are held five days per week. We have 33 different programs, many of which occur multiple times per week. Our objectives for our Health and Fitness programs is to offer choices for all ability levels at affordable prices and to encourage whole person wellness, maintain and improve physical health and balance, to learn about healthy lifestyles, to take an active role in managing one's own health. 9,190 duplicated participant units.

Lifelong Learning - These programs are held several times throughout the week. We have 23 programs which include one time informational sessions as well as on going series. Our objective for our lifelong learning program is to offer programs that are accessible, both physically and intellectually, to stimulate one's mind, to seek understanding, to learn more about self and others. 6,356 duplicated participant units.

It is the Center's belief that fair and just compensation is in the best interest of the Center as a retention and recruitment strategy.

Minutes of Committee meetings are kept to ensure contemporaneous substantiation is documented.
